er, Joel Olea Gomez, was 27 years young. He didn't go home that day. A sad situation for so many people whose life he impacted.


CONSTRUCTION WORKER DIES

The Job Board lets you to search for job postings throughout the US and internationally by applying filters that fit your criteria, and save them by keyword, location, industry, or job function. The Job Alert automated search sends new postings that meet your criteria right to you, instead of having to log in to search for new jobs. You also get help with career advancement to move your career forward or change industry sectors, including using social media for networking, how to work effectively with recruiters, how to give notice, and negotiating salary and benefits. And you have access to expert coaching!

The Risk of Fentanyl and Opioid Use

At our November breakfast meeting, Kelly McKay and Shastity Urias from the DEA and William Perno from SAY will speak to us about the dangers of fentanyl and opioid use. Attendees will learn about the risks of fentanyl, how to recognize an opioid overdose, and how to use Naloxone (Narcan) to attempt to reverse an overdose. People attending the meeting will receive FREE Naloxone/ Narcan Nasal Spray (\$45.00 Value). The opioid epidemic has resulted in record overdose deaths across the United States. Fentanyl can be found in any illicit street drug, including counterfeit prescription pills/tablets, powders, liquids & vapes, blotter paper, and sprays. San Diego County Fentanyl-related deaths increased from 22 deaths in 2015 to 815 deaths in 2022, a 3,750% increase. Teens as young as 13 years old have died from fentanyl poisonings in San Diego County. Join us to learn more about the opioid epidemic. What you learn could save a life!

USDOL launches Severe Injury Report dashboard, providing interactive view of injuries across states

September 4, 2024

WASHINGTON—The U.S. Department of Labor's Occupational Safety and Health Administration today unveiled an online tool giving users the ability to search its severe injury report database and view trends related to workplace injuries occurring in states covered by federal OSHA.

The Severe Injury Report dashboard allows users to search and download data by year, industry, state, establishment name, and Occupational Injury and Illness Classification System codes. The dashboard includes information on all severe injuries reported by employers covered under federal OSHA since 2015.

The dashboard includes information on all severe injuries reported by employers covered under federal OSHA since 2015.

OSHA encourages workers and employers to use the dashboard to learn how severe injuries happen in their industries and use the agency's available resources to help prevent workplace injuries. A brief instructional video is available to demonstrate how to use the dashboard.

Federal law requires employers to notify OSHA of a work-related in-patient hospitalization, amputation or loss of an eye within 24 hours of the incident. The agency's com-

pliance assistance specialists and on-site consultations are available across the country and in U.S. territories to help employers.

OSHA announces meeting of Federal Advisory Council on Occupational Safety and Health on Oct. 17

September 24, 2024

WASHINGTON—The U.S. Department of Labor's Occupational Safety and Health Administration has scheduled an online meeting of the Federal Advisory Council on Occupational Safety and Health on Oct. 17, 2024, from 1 p.m. to 4 p.m. EDT.

FACOSH advises the Secretary of Labor on all matters relating to the occupational safety and health of federal employees. These matters include providing advice on how to reduce the number of injuries and illnesses in the federal workforce and how to encourage federal executive branch departments and agencies to establish and maintain effective occupational safety and health programs.

The agenda will feature remarks by Assistant Secretary for Occupational Safety and Health Douglas Parker, regulatory updates from OSHA, a report from FACOSH's Subcommittee on Best Practices and Lessons Learned, and input from the department's Wage and Hour Division. The agenda may also include presentations on job classifications and Bureau of Labor Statistics data input.

Trends in Workplace Homicides in the U.S., 1994–2021: An End to Years of Decline

Why is this study important?

The number of homicides both within and outside of the workplace decreased from the mid-90s through 2014. While the frequency of workplace homicides did not change from 2014–2021, homicides outside the workplace increased from 2014–2020. Understanding these trends is critical to preventing homicide.

How did you do the study?

We applied advanced statistical methods to data from the Bureau of Labor Statistics Census of Fatal Occupational Injuries and the Federal Bureau of Investigation. We then identified rates and patterns of workplace and nonworkplace homicides

What did you find?

During the study period, 16,497 workers in the United States lost their lives due to homicide in the workplace while 456,494 homicides occurred outside the workplace. Workplace homicides that occurred during a robbery began to increase in 2015. Similarly, shooting-related workplace homicides also increased beginning in 2014.

By occupation, the highest rate was in protective services, with 2.74 homicides per 100,000 employees in 2021. Taxi drivers and chauffeurs were second highest, followed by retail sales. By industry, gasoline stations had the highest rate with 5.55 homicides per 100,000 employees. In 2021, men were more than three times as likely as women to die of workplace homicide. The rate of workplace homicide was highest among Black people, followed by Hispanic and White people.

What are the next steps?

These results highlight the importance of identifying and evaluating methods to prevent workplace homicide, particularly those that occur during a robbery or other crime
